For all adults in Scouting, Safety of our young people must be our first priority, here in Nottinghamshire we are taking this very seriously. We are continuing to send emails out to all adults in Nottinghamshire whose Safety or Safeguarding is overdue.

If your safety or safeguarding is overdue you may have also received a letter from Tim Kidd (UK Chief Commissioner) urging you to complete the training online. Please do this as soon as possible.

It takes an hour, an hour to make Scouting in your section a safer place for you and your young people. Those of you that do not complete the training, you will be asked to attend a virtual appointment review, the outcome will be Renew (unlikely) Reassign (probable) or Retire (possible).

## DBS checks during the coronavirus suspension

The decision has been taken nationally to stop processing disclosure applications and re-checks during the face-to-face suspension of Scouting. This will be the case until the suspension on face-to-face Scout meetings and activities is lifted.

## What this means during the Coronavirus situation

- Volunteers will not be suspended when a disclosure re-check has not been undertaken and a valid disclosure obtained.
- Volunteer line managers will continue to receive the reminder and suspension emails as these are automated through Compass. While this isn't ideal, it isn't practicable nor cost effective at this time to stop these being sent. During this period please disregard these emails (although they may be of use to create a list of those volunteers who will need to process a disclosure re-check when the suspension on face-to-face Scout meetings and activities is lifted).
- Volunteer line managers should not add any new adults during the Coronavirus situation and should not process the suspension of volunteers during this period.

Volunteers whose disclosure expires during this period may continue to meet digitally, following the advice and guidance issued on holding virtual meetings to make sure we keep all members safe.

Processing disclosure applications and re-checks when the suspension on face-to-face Scout meetings and activities is lifted

Once face-to-face Scout activities and meetings resume, new disclosure applications can commence and volunteers whose disclosure has expired will be able to continue in their roles for a limited period before suspension will be necessary if a valid disclosure is not obtained. National will set a date when all volunteers who don't have a valid disclosure must start the process to renew their disclosure. The limited period will be 90 days from that date for those volunteers to obtain a valid disclosure.



## Calling all Explorer Scouts—your help is needed.

We would like you to design the front of a certificate to Recognise the "Time In Scouting" you have given from being in Beavers to the end of your Explorer time.

It should be in an A4 format, include the County Logo, space for the name, Explorer Unit and District of the recipient and space for the County Commissioner to sign and date it.



The rest is up to you.



## Other news in training

#### Wood badge Training

We have taken the decision to suspend all face to face training until September but there are other ways you can do some of the learning to help towards your woodbadge. Over the coming weeks if you are working towards a wood badge for your role and you don't know who your training adviser is you should be notified who is there to help you.





#### **Validation**

What is validation? Validation is about confirming that someone is able to do what they are supposed to be able to do. It is about confirming that the required learning has taken place by checking what the learner has done with it in practice

This is an ideal time when we are not face to face scouting to dust off your training files and sort out the evidence you need to validate your training. The link below gives you some guidelines for the evidence you need.
